Alison Jaggar, Wilson Professor of Ethics, University of Cincinnati, will be a Distinguished Guest Lecturer at the University of Alberta from March 2-14, 1986. Ms. Jaggar is the final speaker in the Women's Studies Lecture Series, which is sponsored by the Vice-President's (Academic) Advisory Committee on Women's Studies and the Faculty of Arts.

Ms. Jaggar obtained her Ph.D. in Philosophy from State University of New York at Buffalo, and in 1982, became a Professor of Philosophy at the University of Cincinnati. She was the first occupant (1984-85) of the New Jersey state-endowed chair in Women's Studies at Douglass College, Rutgers University. She is the author of Feminist Politics and Human Nature and co-editor with Paula Rothenberg of Feminist Frameworks: Alternative Theoretical Accounts of the Relations between Women and Men. She is also the author of numerous articles which have appeared in such journals as Philosophy and Phenomenological Research, Social Theory and Practice and in the books Feminism and Philosophy, and Readings in the Philosophy of Sex, to name a few.

While at the University of Alberta, Jaggar will give two public lectures. The first of these will take place on 5 March, 7:30 - 9:30 p.m. L-1 Humanities Centre. The title of the lecture is "Teaching Sedition: Some Dilemmas of Feminist Pedagogy". This talk will address some of the problems associated with being a feminist in the classroom.





FEMINIST WAYS OF KNOWING

Feminist Ways of Knowing is the theme of the second in the ongoing series of interdisciplinary seminars in feminist theory to be held at Douglass College of Rutgers, The State University of New Jersey. It will be meeting on Fridays, beginning September 6. The seminar will be conducted by Alison M. Jaggar, the first occupant of the Douglass Chair in Women's Studies. Professor Jaggar, Wilson Professor of Ethics at the University of Cincinnati and a Visiting Professor of Philosophy at Rutgers, is coeditor of Feminist Frameworks (McGraw-Hill,1984) and author of Feminist Politics and Human Nature (Rowman & Allanheld, and Harvester Press, 1983).

The seminar is designed to provide a context for scholars investigating alternatives to prevailing gender-distorted ways of living and thinking and offers a forum for critical response to works in 'progress on this theme. In addition, the seminar contributes to developing a network of feminist scholars in the Rutgers area. Papers will be given weekly, mainly by seminar participants with the occasional possibility of outside speakers. Papers will be made available in advance to regular seminar participants. After the seminar, participants may eat lunch at their own expense in the Douglass facilities.

The seminar is open to any feminist scholar within commuting distance of Douglass College. Places will also be saved for four Rutgers graduate

students and two undergraduates. Students will receive credit.

If you would like to participate in the seminar, please write a letter of application stating your background in feminist scholarship and explaining how your work fits the theme of the seminar, and how you could both benefit from the seminar and contribute to it. If possible, please enclose a sample of the work you would like to present in the seminar; otherwise, please describe the work and state when it will be in a form appropriate for presentation. A detailed letter of application will make it possible to create a seminar that combines a diversity of participants with a unified and coherent thematic development.

There will not be time for all the seminar . participants to give a presentation, but some preference in admission to the seminar will be given to active researchers. Feminists outside of the academy are also welcome. Participants in the first seminar are eligible to reapply but will have a somewhat lower priority than new applicants. The seminar will be as inclusive as possible but not so large as to preclude full participation by all its members.

These figures are based on current fares and exchange rates and of course will alter when those things do. Would you be sure to keep any receipts relating to your visit and to your stay here as a visitor; the University's regulations require submission of these with the travel claim at the end of your visit.

Your role as a Distinguished Guest Lecturer and the brief duration of your stay should enable you to enter Canada without difficulty. As an American citizen or a permanent resident of the United States, you may apply for employment authorization at your port of entry into Canada. If you do decide to do that, please carry a copy of this letter with you when you arrive, as well as evidence that you are permanently employed or permanently resident in the United States. You should also be in possession of evidence concerning your American citizenship. In spite of the fact that you are able to do these things at the port of entry, I'd like to suggest that you make contact with a Canadian consular official prior to your departure and obtain these documents in advance of your travel.

We do hope that you will be able to accept this invitation, and I join my colleagues in looking forward very much to having you with us next spring.

Dear Alison,

First of all, thank you for responding so promptly to my phone call last Sunday. Your cv arrived on Friday and our application to the Distinguished Visitor fund is now in the hands of those who make the decisions. We should know about that source in a few weeks and then we intend to apply to our federal Government for the remainder of the funds. That, unfortunately, will take a little longer for a decision but to all intents and purposes, we see no problems to finding the funds to bring both you and Dale Spender to our campus next academic year.

We would dearly like to have you here for a minimum of two weeks in March of 1986. That is what we have budgeted for and that also is the minimum length of time Distinguished Visitors must stay in order for us to receive funding. I certainly appreciate your feelings now about wanting to stay put for awhile but perhaps by next year, you'll feel a little differently. Also, we should know about the funding well in advance so that you will have plenty of time to plan around it.

I have enclosed some information for your perusal. First, there is a project proposal for which we have now received funding. It will give you some background on who we are and what we are trying to do here. Our deliberations are going well and we anticipate handing the Vice-President our recommendations by the fall. Then, of course, the real work begins which is why we are organizing the speaker series. If all goes well, Dale Spender will be here for two weeks in September; there will be four speakers for two or three day visits between then and February, and you will draw the series to a close in March. As we choose the other four speakers, I will keep you informed.

Second. I have enclosed the schedules of the visits of two Distinguished Visitors who have just been here. One in my own Department (Bruce Kidd) and the other for Margrit Eichler who was brought in by the Women's Program in the Faculty of Extension so that she was all over the campus. Regardless, it would be up to you to say what and how much you would like to do and we would go from there. Incidentally, we have requested a \$2,000 honorarium which unfortunately will be in Canadian dollars but I hope it is agreeable to you. All travel and living expenses would, of course, be covered.

Finally, I have included a recent paper of my own which you might find interesting. As you can see, I think very highly of your book and each time I read it, I find something new. It is quite masterful.

Please let me know if there is any further information I can provide for you. I do hope this all works out, that you will agree to come as it would be a very great personal pleasure to meet you.

Thank you and I will be in touch again once we have our funding firmed up.
