## **Research Institute Process: A Community of Researchers**

 Recognizing that feminist researchers may appear in many occupations, including professors, clinical practitioners in various fields, social activists, independent thinkers whose primary work is homemaking, etc. Sept. Ko/87

Setting a task that will bring together some of the women in that community so the institute can begin.

3. The first task could be selection of the first two or three research projects for the institute, and working out the institute structure that would make it possible to complete those projects.

4. Further tasks could involve further meetings.

5. We could accomplish this task in a full day of work, perhaps a Saturday. However, we might se wise to "book" two consecutive Saturdays to make it possible for additional work to be done, or to develop a stronger process.

6. We would need to decide who to invite to this session, where it would be held, what documents would be distributed in advance, what procedure would be used for getting possible projects to the group for discussion, how we would handle lunch and snacks, what would be done with the decisions or recommendations of the group.

7. I don't know if she is here or if she would do it, but rather than hiring a short term worker for the institute per se we might ask Sandy Susut if she would organize that meeting for some dollars.

Out of it should come not just the projects but the first structure of the institute, the beginning which would then evolve as we worked.

9. The lengthy document could be distributed, or the (not yet written documents) proposed earlier about the institute...they would all be seen as draft documents which this group could modify.

10. If we define this as a community of feminist researchers, we may reduce some of the categorizing problems that have plagued us. However, we still need to recognize some of the divergent interests that we may have as women, and develop an imagery for the institute which will make it possible for feminist researchers to recognize when their research is most appropriately carried out at such an institute. (In some ways the film research on the Edmonton Grads presents a partial model I think, as well as the interdisciplinary and issue focused research we have described earlier). We also need to be able to realistically address the interests of divergent communities, such as the university, action oriented women, and perhaps women making their living by providing various types of services to women. #### September 16, 1987. Report from Marilyn

A one day meeting on Women's Studies will now precede that conference and I will also attend it. I am using my Faculty travel money, which will at least pay the air fare, and requesting some meal and accomodation costs from the organizers (if they get SSHRC money). I may still come back to the committee for \$100 or so but it should not be more than that. I will bring back information, and send them to both committees.

- <u>Memberships</u>: Decided not to renew our membership in the National Women's Studies Association, to renew our Canadian Women's Studies membership, and to become participants (\$25/year) in <u>Movement</u>. Leslie
- 6. Women in Philosophy Conference. Sept. 16-18, 1988: Marilyn will meet with Lynda Lange and Debra Shogan to discuss more specifically the kinds of tasks they would like the committee to take on and then report back to the group. Marilyn
- 7. There was some concern that we do not have community representation on the committee, since Lisa W. has not been to the last few meetings. Marilyn will phone Lisa to see if she is still interested in being on the committee. **Marilyn**

#### 8. Discussion of the proposal for a Women's Research Centre:

-Conceptual fuzziness around "feminist research." Not clear what is meant by "interdisciplinary research". We need to discuss these things but not sure if they should go in the document for committees to tear apart.

-Some practical concerns like should we have letters of support, should we cite the number of women on campus, number of publications?

-Pg. 9, suggestion that a video recorder would also be a useful piece of equipment for the committee to have.

-Refer to other institutions in addition to OISE, even if we just list them.

-Include what we've already done in terms of Research Centre meetings and the presenations.

-Structurally, the summary and document are not parallel. Incorporate summary stuff into the document. The three focii are problematic, especially the distinction between numbers 1 and 2.

-Mention how other research institutes bring in funding.

-Pg. 3, end of 1st par.; "...but on the whole our contribution to the literature is not significant." Concerned about our presentation of self here. Should represent ourselves more positively.

-The section "Rationale for a Feminist Research Institute" really focusses on academics.

-Perhaps "Research Objectives of the Institute" should come earlier.

-Three terms that may not be clear to non-feminists: community women, action research, and ecology.

-Should emphasize that we want the research published.

-Problems with concept of "honourary membership" and with some of the people listed there.

-Make the director full-time now and perhaps half-time later.

Discussion around whether we have changed our goal of getting the proposal through and the centre established on paper as quickly as possible. Agreed that one more draft will be necessary, but that the proposal should then be ready to go. Rebecca and Marilyn will get together to write the next draft. **Rebecca, Marilyn**

#### Did You Know?

he role of women in society has changed dramatically in recent years. The facts behind this change may surprise you.

- The Facts
- Many women can now expect to spend at least 25 years in the paid work force.

The traditional single-income family is no longer in the majority. In Alberta, in 1982, only 13 percent of husband-wife families were supported by the earnings of the husband alone.

In 1987, approximately 62 percent of all adult women in Alberta are in the labour force, the highest proportion of any province in Canada.

The majority of women still work in clerical, sales and service jobs, which are generally lower paying with fewer opportunities for growth and development.

Many women enjoy the work that they do. Some women, however, choose their jobs without being aware of the many career options available to them. What is Stepping Stones?

## Stepping Stones is about options.

The Stepping Stones program is intended to help girls and young women to become more aware of the many career and educational options available to them. It is a learning resource which also provides boys and young men with the opportunity to learn more about career choices and the changing role of women in society. Stepping Stones gives all students in the classroom the chance to meet with women from a wide variety of jobs and fields of study, particularly in areas where women are under-represented.

Stepping Stones operates in the classroom during regular school hours. Women who work and study in non-traditional fields such as construction, engineering, transportation, science and hightechnology participate in the Stepping Stones program. These women act as role models by speaking to young women and men about their education and training, their jobs, and how they combine their work and/or studies with other personal commitments.

The **Stepping Stones** program is a resource to support the career components of the new junior and senior high health curricula and was developed by the Alberta Women's Secretariat in consultation with Alberta Education and Alberta Career Development and Employment.

#### How Does Stepping Stones Work?

Registry

The **Stepping Stones** program is designed for students in grades where course selection usually affects future educational and career choices. The program has three major components:

Women representing a wide variety of occupations make classroom presentations to girls and boys in grades 8 and 9.

Women attending post-secondary institutions in a broad range of programs and courses of study make classroom presentations to girls and boys in grades 8 and 9.

Young women in grades 11 and 12 are matched with women from a wide variety of occupations for visits to the workplace.

The Alberta Women's Secretariat is developing a registry of women who are interested in volunteering their time to act as role models for young students. The registry is available to all schools participating in the program.

- 2. Sharon Jamieson will not be coming to today's meeting in order to allow more time for discussion of the research centre proposal. She will send us a letter outlining her ideas on computer networking and will come to a future meeting if we'd like.

Both Vangie and Sande feel that they would like to resign from the committee due to other commitments. Vangie is willing to look for a replacement for her from within the Faculty of Nursing. It was agreed to ask Vangie to do this. Marilyn will contact her. Marilyn

3. <u>Business arising from December minutes</u>: Pat Rooke and Cathy Cavanaugh have agreed to present their research at the March meeting of the Research Centre.

Rebecca has some documentation from Health and Welfare re: what they will be doing on daycare. She suggests we write a letter to them if we want to proceed with the daycare issue.

Rebecca sent a letter of support to the Graduate Student's Association regarding their proposal for a graduate program in Women's Studies.

4. Space: The Research Centre has been given a house at 11043 90 Avenue. The house is to be shared with the professors emeritii. We should use the house as much as possible in order to demonstrate our need for such a space. It was decided to hold the next Research Centre meeting there on February 8. Also, Marilyn, Rebecca and Lisa A. will begin to use the office space to work on their own research. This raised the issue of how the committee will determine who will be able to use the space. We need to get a phone, answering machine and some furniture. Jean suggested that the university has a pool of furniture that we could draw from.

The International Student's Centre went to Native Studies but it may be available again in May and we could indicate at that time that we are still interested in that space.

## 5. <u>Change of Heart</u>: Lisa will introduce the facilitator. Lisa A.

6. The revised edition of the Research Bank Information Form was distributed. Agreed to start using it and see if further modifications are needed.

Lisa will distribute the forms to graduate students in English. Lisa A.

Leslie will distribute the forms to AWA, WISEST and the Women's Studies Committee in Arts with a covering letter directed to "you and your grad students." The letter will indicate that the forms will serve as a data base of researchers doing work about women, and will also ask if the individual would consider housing their research in the Women's Research Centre.

7. Proposal for a Women's Research Centre

Meekison had two comments in response to the proposal: 1) if we don't want space, he can approve it immediately; if we do want space, it needs to go through some channels, 2) he was concerned that if we get into big fundraising that it may conflict with Women's Studies fundraising.

#### Discussion of the proposal

- Could we elect half a board at a time to allow overlap.

- Wording, pg. 2, par. 2: replace "centres" with something like "groups of researchers."

- Confusion around the different types of membership; is a subset in the second group - needs to be clearer.

- Rebecca would like to see Athabasca represented as a joint partner in the venture. Argue that the two universities support this centre, that it is a cooperative effort.

- Need strong argument as to why we need a centre: "While there are pockets of research . . . need to be pulled together." Notion of isolated scholars, etc. 2nd par. on pg. 1 starts to do this.

- Pg. 1, par. 2: change "it is difficult to have enough women" to "we don't have enough women."

- Proposal seems to be an amalgam of things. Need to focus directly on what we want from the administration; e.g., 1st par. does not serve our purpose.

- Tie in with *The Second Decade and Beyond*, GSA proposal, etc. Pull interdisciplinary idea out of 1st par.

- Need a different proposal for Advanced Ed. Would want to extend the community involvement aspect, whereas might want to downplay this at the university level.

- State that the centre is supportive of Women's Studies and will benefit W.S.

The main purpose was to discuss the Reseach Centre, and in general to touch bases with Dr. Meekison. We also wanted to ensure that he had the updated list of the membership.

Position paper:

Task Force on Graduate Program in Women's Studies

November 18, 1987

We need ... to know more about women and to pay greater attention to what is known. As the study of women becomes 'legitimate', there will be a greater emphasis on what has been done and greater access to what is now being done." -Marylee Stephenson, <u>Women in Canada</u>

Women's roles in the family, in the economy, and in academia are undergoing profound changes - changes that affect all of us. Women now outnumber men in Alberta universities; three out of four Canadian women will be financially independent at some time in their lives, and only an average of 13 out of every 100 Alberta families constitute the "traditional" family in which the male is the sole breadwinner. (Edmonton Journal, "Women in the Labor Force", Oct. 19, 1986; citation from Statistics Canada) Education has played a major role in this remarkable change; Judge Rosalie Abella, in a 1984 Royal Commission report on equality in employment, identifies education, the "myth killer and skill giver", as a crucial agent in this change "Dramatic changes in the school system" are process. required to adequately fulfill both these functions, she advises.

We propose that the University of Alberta establish a graduate program in Women's Studies for the following reasons:

Firstly, there is a great need for a program focusing on women's studies and gender-based research issues. At present, interested members of the university feminist community are circulating a petition appealing that such a program be established. We believe that a great deal of support for this program already exists: attendance at various women's studies lectures and seminars has been consistently excellent, and interest in women's studies is at a very high level. Unfortunately, the University lacks graduate credit courses in women's studies that can be taken towards a women's studies degree; it is difficult to focus on women's studies at the University because of this lack of a structured program. Those interested in women's studies must use a "hit-or-miss" system when enrolling in courses, with no guarantee that any single course will have a particular emphasis on women's issues.

Secondly, establishing a formal network of courses for potential students would formalize and speed up a very involved process. Presently, a student interested in pursuing a graduate degree in women's studies must first approach the Faculty of Graduate Studies and Research for approval of his/her courses. This route is extremely circuitous; it is also, inevitably, inconsistent, as there are no formal course requirements and no one program coordinator for graduate women's studies. In practical terms, women's studies students might not have any courses in commmon. No theory or introductory courses in women's studies are offered at the graduate level.

Thirdly, it is not only a programmatic structure that is needed; students interested in women's studies are now "out in the cold", unable to exchange ideas, discussion, and concerns. These students lack the "critical mass" so necessary in a university community. We believe that founding a graduate program in women's studies would be a positive influence on these students: under the guidance of a department, students and faculty could freely and easily exchange ideas. It is difficult now for students (both those presently attending the University and potential students) to become acquainted with each other, to discuss their studies, to design programs, or to seek supervisory guidance.

Fourthly, a graduate program in women's studies at the University would be something of a trend-setter: only four other universities in Canada, and none on the Prairies, offer such programs. To establish a graduate program in women's studies would pull in a heterogeneous group of students, attracted by the reputation of the University of Alberta as an innovative and research-oriented institution. To now establish a women's studies graduate program makes good sense in view of the position taken in <u>The Next Decade</u> <u>and Beyond</u>, which emphasizes the importance of graduate studies at the University and recommends that FGSR enrollment be raised to 20% of all students.

We propose that this program should take an interdisciplinary approach, with a required course in theory or methodology. The strength in this approach lies in its diversity. In this framework, the nature of women's studies demands a structure that transcends departmental boundaries: women's issues and roles in history, literature, politics, sociology, business, law, medicine, theology, education, and the sciences could be successfully explored in this framework. This would allow the student to choose an emphasis which suited him/her, whether in literature, sociology, history, or the sciences, but retaining a common core of theory and methodology courses.

In other women's studies programs (for example, the undergraduate program at Simon Fraser University) professors have joint appointments with such departments as Psychology, art, History, Computer Science, and Philosophy. Existing faculty could make up the nucleus of the program; they could then be appointed to joint semester positions in women's studies. As at SFU, feminist scholars could be invited on a visiting or exchange basis to teach courses. Also, additional courses in departments outside women's studies could be considered for credit in the new program, provided those courses have a high women's studies content. There is also the possibility that those undergraduate women's studies courses scheduled to begin in 1988 could be upgraded for graduate studies. This would be a low-cost approach to the establishment of a new program - helpful in these budget-conscious times.

We feel that it is important that women's issues are researched in the depth and breadth they deserve. As an historical, political, and sociological phenomenon, contemporary changes in women's roles, and the issues arising from these changes, should be examined closely; they relate to nearly every facet of everyday life. To establish a graduate program in women's studies would signal the University's openness to innovation, but also indicate its willingness to listen to those in need of research facilities and guidance for graduate work in a topic that affects all of us.

### Additional Notes:

Since our meeting with Dean Chia of the Faculty of Graduate Studies and Research on December 2, the following possibilities for reaching our goal have been established:

1. Those interested in women's studies have a dire and immediate need to meet, discuss research and exchange ideas. Therefore, we feel that the establishment of an Institute or Center for Women's Studies on campus is essential. This Center could be administered by a director appointed by its Board of Governors; University funding could be requested in order to obtain office space, publicity, etc.

2. Two options were put forth by Dean Chia, which he termed "short-term" and "long-term". The former is that an existing department be approached to act as sponsor for the women's studies graduate program; the department would put this proposal to a vote of its Department Council. This way present teaching staff and exisiting facilities could be used to set up the program. Dean Chia suggested the Sociology department, which is a large department, has a large graduate student population, and also has a fine reputation as a research department. However, it must be stressed that this is only the beginning - other departments could also be approached, among them English, Comparative Literature, Political Science, Psychology, History, or any of several others. This sponsoring department would then be able to award degrees in (for example) Sociology/Women's Studies. We can also see the Women's Studies Institute having a great deal of contact with this department, perhaps in an advisory role, and certainly in the role of publicity and directing interested students to this department. This approach is by far the simplest and least costly.

The latter approach, which is to go through the established mechanisms in General Faculties Council and then through the Academic Development Committee, requires approval time of three to ten years; it also raises problems of money (there is little or no chance of a new program or department being allocated money in the present bad times for academia), office space, equipment, and the possible hiring of new professors.

3. What then is the role of the Graduate Students' Association? Firstly, the task force requires help in establishing the level of support and interest in a graduate program in women's studies among the graduate students already on campus. In June the GSA gave the task force a mandate to "review the need for establishing a graduate studies program in Women's Studies"; we believe that such a need exists and should be acted upon, but we need GSA support and endorsement in order to plan our actions.

We would also appreciate the ideas and support of other groups on campus who realize the need for a graduate program in women's studies. It is only through the cooperation and help of interested groups that we can achieve this goal.

Eventually, as other groups are defined and develop, women will be able to more easily find a niche which is comfortable for them.

Participants should make the following somewhat loose committment: that they will be willing to present their work in its initial stages and in its development within the centre or institute; that they will keep other women in the centre informed of the progress and general direction of their work; and that they are willing to be personally associated with the centre and have their research work associated with it. I suggest "loose" because they should recognize they can change their mind if things don't seem to be working, but the initial committment should be there.

The research centre should be seen primarily as a place for support related to research, that is:

-a place where feminst researchers can discuss their work and where they know they will get attentive helpful ears (no matter how ill formulated their plans are).

-a place where researchers can find others to brainstorm with when

they hit a seemingly impossible block in their research -a place where others will have ideas about obtaining funds, although there may be no or few funds attached to the centre -a place where research methodology is constantly being discussed, not in the sense of statistical or even scientific canons but in the sense of "how do we come to know the answer to these questions?" "what does our knowing have to do with action in relation to some questions?" "is the way that we have chosen to seek the answer the best way?or is it in any way harmful to women?or helpful to women?"

 a place where others will have ideas about gathering existing information on the question, whether from data-bases or library resources or other researchers.

Someday it will be a place with some administrative, technical, and maybe even research assistant type of support, but that we cannot do without money so it will have to wait.

(Rosemary and I worked through these ideas last Monday night; we think they will provide a means of getting the research centre going).





### December 13, 1988 Women's Research Centre; meeting with Meekison

### Text of note sent to Cathy Bray re: meeting Dec 12 with Meekison.

I met with Meekison yesterday to check on the procedure now for formalizing the Research Centre's relationship with the two Universities. Rebecca and I met with Ross Paul and Peter in about May as I recall and it was agreed that we would do something formal once the centre had been approved by all levels of the U of A.

Meekison suggested that I sit down with someone from Athabasca and draft what would be a letter of understanding between the two universities. I am then to take that to Dave Norwood (who has been involved in a number of such agreements with other universities) to see if he can see any problems. It then could come from the U of A to Athabasca (i.e. to Ross) to be sure there were no problems, and would be changed or signed. His suggestion was that it be quite simple and short and include:

a)U of A contribution (space, overhead)

b)Athabasca's contribution (Rebecca and I had talked about computers and Ross had thought a little money; we could work on this a bit between the two of them)

c)shares of operating budget (we talked about 20% Athabasca and 80% U of A in our original meeting; we might test other figures)

d)reopening clause (how do we renegotiate the agreement if it does not seem to be working at any future date

e)amendment clause.. how do we amend it given some need for a change which might not be major

f)governing structure... for example, if/when we appoint a director and assuming it is a university position, who appoints her, reviews her for promotion and tenure, etc. Also, what are our reporting lines within the universities.

We don't need to rush this, but it should be done in the next two months or so. I am communicating with you as "Athabasca" at the moment by the way, but I think it might be a good move on your part to include Barb in this and do it over lunch or in a hopefully short afternoon meeting. We could take it to the last meeting of the co-ordinating committee to see if they see any big problems (that would be perhaps better than the developing collective, although I am not averse to taking it there also).

This sounds like a big item, but I think the key is to keep it simple and treat it as meeting necessary administrative requirements but to write it in a way that won't tie the Centre's hands unduly. (i.e.the centre collective's hands). We'll write in a small operating budget under c) and see if that flies anyplace, and then hopefully not have to deal with the administration a lot after that.

The next move, once all of this is done, will be to formally be placed under the Vice-President Research at this university. Meekison agreed with me that it would not be appropriate to do that until the negotiations with Athabasca which he has already begun are completed. (He and Ross Paul seem

to have a good communicative relationship; I gather they see each other at various formal meetings).

Finally, he advised me to write to McCoy, which I will do, (about money). That is fyi, it does not matter if you are U of A or Athabasca.

End text of note to Cathy.

I don't think I need to add much to this in relation to the conversation with Peter Meekison. He sees it as "drawing up a researach centre agreement". David Norwood is the Associate vice-president under Warnock and I spoke with him on the phone this morning. He said wait until we had drafted something and then bring it to him. I said it would likely be after Christmas and he said no problem.

Meekison also said I should send a note to Elaine McCoy who is very interested in the centre. Horowitz was on a phone-o-thon with her last week and talked about the Centre and she was very keen. Meekison is to send me the note from Horowitz to him about it, but he thinks a brief letter asking if we could apply for a grant enclosing a copy of the document would be enough. It would not hurt after that to talk to "whoever we know in the secretariat" (I was thinking of Janina actually, but others might be useful too). He did not mention it, but I must send a copy of the letter to him. I have marked it on my calender for Thursday or Friday, and will get a copy of the proposal off MTS tonight (I need extras to distribute, and should have some for the library people I will meet with on Thursday of this week).

I will keep my note following the meeting with Meekison on file. It is scratchy, but has a lot of information on it.

# Research Institute Process: A Community of Researchers

 Recognizing that feminist researchers may appear in many occupations, including professors, clinical practitioners in various fields, social activists, independent thinkers whose primary work is homemaking, etc.

Setting a task that will bring together some of the women in that community so the institute can begin.

3. The first task could be selection of the first two or three research projects for the institute, and working out the institute structure that would make it possible to complete those projects.

Further tasks could involve further meetings.

5. We could accomplish this task in a full day of work, perhaps a Saturday. However, we might we wise to "book" two consecutive Saturdays to make it possible for additional work to be done, or to develop a stronger process.

6. We would need to decide who to invite to this session, where it would be held, what documents would be distributed in advance, what procedure would be used for getting possible projects to the group for discussion, how we would handle lunch and snacks, what would be done with the decisions or recommendations of the group.

7. I don't know if she is here or if she would do it, but rather than hiring a short term worker for the institute per se we might ask Sandy Susut if she would organize that meeting for some dollars.

Out of it should come not just the projects but the first structure of the institute, the beginning which would then evolve as we worked.

9. The lengthy document could be distributed, or the (not yet written documents) proposed earlier about the institute...they would all be seen as draft documents which this group could modify.

10. If we define this as a community of feminist researchers, we may reduce some of the categorizing problems that have plagued us. However, we still need to recognize some of the divergent interests that we may have as women, and develop an imagery for the institute which will make it possible for feminist researchers to recognize when their research is most appropriately carried out at such an institute. (In some ways the film research on the Edmonton Grads presents a partial model I think, as well as the interdisciplinary and issue focused research we have described earlier). We also need to be able to realistically address the interests of divergent communities, such as the university, action oriented women, and perhaps women making their living by providing various types of services to women.

I want to keep this short, to provide only a possible discussion outline for us. So I better get away from the word processer!

2. Funding. Marilyn will continue to solicit core funding from various places, as long as the funding is not conditional on our commitment to any particular agenda.

The University conference fund responded positively to our request for funds. They granted us \$640.00.

3. Future Direction of the WRC. It was agreed that the best process for determining the future direction of the WRC was to open the question up during the plenary of the forum. This question can also be addressed at meetings that will follow the forum, to which all participants of the forum and other interested persons will be invited to attend.

There was some discussion regarding the position of the Chair of WRC, centering around two points: a) WRC requires a Director for the house and a WRC Board requires a Chair, and b) ideally, these should be two different persons. However, Marilyn is functioning in these two capacities, which is acceptable for the time being. Further to the WRC Director position, Marilyn mentioned that funding for this position is meant to exist. At first, it could be a part-time position, and eventually turn into a full-time position. At that time, we would go to a full-fledged hiring process to select the Director.

4. Sharon presented a proposal regarding the assistance of WRC in making possible a graduate studies program in Women's Studies. See attached.

Cathy suggested that Sharon should, if she hadn't already done so, approach Shirley Neuman and Winnie Tomm with this proposal. Sharon could also speak to the students who had petitioned the Dean. Cathy suggested that it was premature for WRC to be involved in graduate degree programs, and that these issues can be raised again when WRC is more established.

5. Plenary scheduled for the Feminist Research Forum. Marilyn affirmed that it should be an information session, not a major working session. It should be at that point that an invitation is extended to all who may be interested to attend a meeting, to follow the forum by a number of weeks, which will occur at the WRC house. At that later meeting, work can begin on further development of the WRC. Suggestion that this meeting be Nov. 5, a Saturday from 10 a.m. to noon. Other possible dates were ruled out due to In•Sight on October 28, 29 and 30, and later in Nov. will conflict with the ASWAC Assembly and the Federal election. We will need a flyer to distribute following the Forum to invite and inform of this meeting.

Cathy remarked that a second meeting should follow after this first post-forum meeting, at which a research agenda can be set.

It was agreed that this is an acceptable process for the development of the WRC.

-This could take time and we discussed alternate ways to get our proposal going, in the meantime. We discussed possibly merging the Women's Resource Centre within a Women's Institute (Dean Chia's idea) and forming a Women's sub-committee, made up of interested academic staff, who would supervise 'special degree' interests. Although the graduate degree would be sponsored by any and potentially all faculties, the actual program, thesis-committee, supervision would come from the sub-committee. This has the advantage of retaining the multi-disciplinary approach and taking the load off any one particular department. This Institute could even set up a mandatory methodology course, and provide the networking, seminars, research focus needed for women in the program. The Women's Study Committee in Arts would act in a consulting capacity and eventually have to be involved with this; they could potentially work towards having a degree program out of Arts. At the moment, the members of this committee are prioritizing the undergraduate program.

# Minutes of the Co-ordinating Committee on Women's Studies, Meeting of September 6, 1988

Present: Jean Lauber, Jan Williamson, Bridgette Elliott, Lisa Austin, Marilyn Assheton-Smith; Regrets Cathy Bray, Margaret-Anne Armour and Sharon Frantz-Lutzer

 There were no changes proposed to the agenda. The minutes of the last meeting are not available as they did not get turned in by the recorder. Our recollection of that meeting was that the primary decisions were to designate a subcommittee to plan for the fall opening of the Research Centre, and to leave the progress of the Research Centre proposal through committees to Rosemary and Marilyn.

2. The Research Centre proposal is moving reasonably well through the committee stage, but still has one step to complete. Marilyn and Dr. Meekison met with Ross Paul (academic vice-president of Athabasca University) and Rebecca Coulter (in her capacity as coordinator of Women's Studies at Athabasca University) on June 15 to briefly discuss the relationship between the two universities. No major problems were seen, and Athabasca University had by this date approved their participation.

Marilyn and Rosemary met with the Academic Development Committee on June 22 and the Planning and Priorities Committee on July 14. There were a number of questions raised, primarily of a practical and structural nature, but in both cases approval was granted without requests for change. Marilyn then met with the GFC executive on August 8. The major concern raised in this context was that the proposal did not sound as if the Research Centre would be open to men. (My position has been that it will be open to researchers who are woman-centred or feminist in their overall orientation, and that does not ipso facto exclude men although we would not expect many men to participate; generally this response has been satisfactory). In this case it was requested that we make changes in wording so that the frequent occurrence of women as either a noun or adjective would be reduced. Ellen Solomon provided guidance and gender-free terms were adopted in a number of cases in the text. No other changes have been made or proposed, so these changes were considered editorial and the committee was not called together. It was noted in the GFC executive meeting that the Research Centre will come under the Vice-President Research for purposes of administration at the University of Alberta, not the Vice-President Academic. At Athabasca University it will remain under the aegis of the Vice-President Academic.

The final presentation will be to the General Faculties Council on September 26 at about 2:40 in the afternoon. Marilyn will be there to speak to the proposal. It was agreed to ask Cathy Bray, from the Women's Program and Resource Centre of the Faculty of Extension, Margaret-Anne Armour of WISEST, and Winnie Tomm of the Women's Programme in the Faculty of Arts, if they would consider attending that meeting in the gallery in case questions were raised which related to their programmes.

3. Plans for the Opening Conference on Oct 21/22 are proceeding well. We discussed the program and proposed a few changes. That subcommittee (Jan Williamson, Marilyn Assheton-Smith, Margaret-Ann Armour, Aureen Costuras, Lisa Austin, Diana Chown, Andrea Harbour, Cathy Bray, and Bridgette Elliott will meet for their final meeting on the evening of Tuesday September 20 at the Research Centre House).

4. Status of the Research Centre House. We are using the space much more now, both for holding meetings and for researchers. The emeritus professors are also getting more active, and have made contact with Marilyn (and earlier with Rosemary) about our shared use of the space. No problems are foreseen, but we have asked that we be consulted before they make decisions about the common space (they have agreed to do that). Telephones will be put in as soon as possible, including jacks for computer hookups. All files of the committee are now in this space.

5. Sharon Frantz-Lutzer planned to describe the graduate student's position vis a vis a Graduate Programme. She missed notification of the meeting, but will be invited to comment at the next meeting.

6. Committee Budget. A tentative budget was presented, based on our current balance in the 64 (trust) account. We identified some items which had been omitted (our commitment to the Women and Philosophy Conference), and recognized that the budget figure for the forum may be low, but otherwise accepted the budget. If followed, it would leave us about \$4000.00 at the end of the fiscal year (March 31, 1989). However, it must be seen as tentative, as a number of changes will no doubt occur.

As part of this discussion, we agreed to hire a clerical/ do everything worker for about 10 hours a week again. There was agreement in the committee on one candidate as a possible worker, but Marilyn was to canvas committee members not present before hiring. (Note: as a result of that process two other possible candidates have been identified). Marilyn will proceed to interview and make the hiring decision as soon as possible. It was agreed that this relatively "closed" procedure which requires little time was appropriate for hiring for such a few hours, but recognized that if we are able to hire full-time at a later period we must go to a full-scale hiring process. 7. Committee membership and possible changes:

It was noted a number of changes have occurred over the summer with Rebecca Coulter off to Ontario, Robyn Mott no longer a full-time student on the campus, and Rosemary Liburd feeling that she must resign from the committee. It was agreed that Marilyn should approach a few possible members who have been considered previously, but make clear that we are likely in a transition from the more general committee to a research committee and we did not know for sure how long this process would take or what the ramifications of it were.

We agreed to indicate that we would carry on as the interim board of the research committee for up to an additional year if necessary, to provide formal continuity during the transition period. However, we would not preempt a process which might occur at the October forum in which people there might have an interest in being involved in the Research Centre.

Finally, given the fact we are in this kind of transition, the committee persuaded Marilyn to continue to carry the chair's responsibilities for a period longer.

8. Other than brochures etc. the major mail received through the summer was a letter from the Emeritii, and a request from Olds College to attend a meeting on Education and Rural Women on September 22.

9. The next meeting is set for **Wednesday October 12 from 10 a.m. to 12 noon at the Research Centre House, 11043 90 Ave.** We agreed to focus primarily on the work and structure of the committee as we move through the transition period to the Research Centre. In addition we will address:

-funding

-outreach to other centres (agreed now to let people in Calgary and Lethbridge know about the forum Oct 21/22)

 -the situation in regards to the hiring of women in the university (a brief discussion was held but it was decided to return to this topic at the next meeting).

## Notes from Meeting of Research Conference Subcommittee, Meeting of Sept 1 1988.

Present: Aureene Costuras, Sharon Frantz-Lutzer, Andrea Harbour, Margaret Ann Armour, Marilyn Assheton-Smith and Jan Williamson; Regrets: Bridgette Elliotte, Cathy Bray, Lisa Austin, Diana Chown not in town.

### 1. Progress on Session planning.

a) Dorothy Smith. Jan reported that her talk will be titled "Our Time Has Come: Celebrating Feminist Knowledge." Her flight times have been confirmed and she will arrive Friday Oct 20 and leave Sunday Oct 22. Jan will meet her at the airport and generally take care of her throughout her visit. Jan will also introduce and thank her at the Friday evening talk.

Marilyn is to arrange to pay her for her airline ticket (she has already booked it).

We agreed to pay her an honorarium of \$250.00, recognizing that as strictly a token honorarium given the quality of her work.

b) Aureene reported on behalf of Lisa that she has had confirmation from Shirley Neuman as a presentor at the session on English literature, but has not yet had confirmation of the others.

c) Lisa also had not had confirmation about the Women and Philosophy session. (Following the meeting I received information that Lisa had just been sent a message that Debra Shogun has agreed to organize that session and it is organized).

d) Women and Equity in the Work-Place; Aureene was having some difficulties with this session, but a number of possibilities still exist:

- Pat Atkin from Ft MacMurray

-Carol Wodak from Human Rights Commission

-Shirley Steele at CEIC or others there

-Murielle Stanely-Venne re Native women

-Nancy Langford

Marilyn and Aureen will continue to work on this to see if it falls into place.

 e) Athabasca Participation - Marilyn reported on a number of phone calls with Athabasca women; they essentially recommended that we wait until their new women's studies staff member(s) are onstream. They thought it would certainly be possible for at least one of those new women to present research and to give some profile to Athabasca at the conference, but they did not see any possibility of them being involved in the planning. Marilyn will continue to work on this session, but it may not proceed.

f) Applied Feminist Research - Andrea has talked to Jane Hazlett at ASWAC and Jane Templeman at Options for Women. Both think they should participate and are willing to try to arrange something. Andrea has asked them to talk about how and where they gather their material and statistics for briefs, and what they have in the way of resources that other people could draw on. Andrea will also see if the nascent Reproductive Technology group in the city would wish to be involved in this session. It looks like it will proceed, but there is a little more work to do on it.

g) Women and Political Involvement - was a new session which was identified as a result of other phone calls. Julia Ann Legras would like to talk about her research on that topic. We thought possibly a session which added a talk on Irene Parlby (maybe Cathy Cavanaugh would look at her research from this perspective) and a talk by someone active in a current woman's campaign could be very good here. Muriel Stanley-Venne's name came up in this context again, as did other women currently running for office. Marilyn and Aureene will try to fill this one out quickly.

h) Feminist Psychology - Jan had talked previously with Cheryl Malmo and Rosaline Spricer and both were quite willing to present work in this area. We suggested adding a third, and Jan will call Rosemary Liburd or maybe Donna Anthony to present their "fifteen minutes" ; if Rosemary agrees to be the third maybe Donna would be willing to chair the session.

i) Feminist Theology - Sharon thought that Donna Coolue (sp?) would be interested in talking about her work which overlaps psychology and theology. Sharon will ask her, and Marilyn will approach Fran Hare and Randy Warren at St Steves to see if one of them would be interested. (Note: Jan points out that is the time of Paulo Freire's visit to the city and St Steves is very involved in that; it will likely present problems but we will see if anything can be arranged even so). If all of these sessions go we will have nine rather than six; we did not see that as a problem as we thought ten to fifteen people in each session would really be the ideal number. That is, we would like a "forum" rather than a "paper's read to an audience" type of conference. If we have nine sessions they will be run as three concurrent sessions in three time slots.

Procedurally, we agreed that the session organizer should now send a letter to each person who has agreed to participate (whether presenting their research or chairing a session), outlining her expectations and who else would be in the session, and reminding the participants of the dates. Immediately after Thanksgiving a final letter will go to each participant from the overall committee chair, thanking them for agreeing to participate and confirming exact times for their sessions (this will need to be confirmed orally before that date).

Plenary session: generally agreement with the plan presented in the agenda notes, but it will be further discussed in the full committee meeting on Tuesday morning.

### Conference timing and space test:

No major problems but some proposed changes in times, catering provisions, and a renaming of the event to a **Feminist Research Forum**. In the case of catering Margaret-Ann reminded us that Lister Hall conference centre now insists on priority for catering on-campus events. The food is generally good and the price reasonable, so that is not a problem. Marilyn will contact the Food Services at Lister Hall about:

-Friday's wine and cheese

-Saturday's refreshment breaks and lunch

-arranging the liquor license for Friday p.m.

-Some uncertainty about where to have the wine and cheese and the food, but general agreement that we should remain within the contiguous space. Marilyn will check the front foyer, the back open area, and the largest breakout room to see which would be most suitable.

-recognition of a need for people to sit at the registration table on Friday evening and Saturday morning. Ideally should be two women to register participants, and one woman to have forms or a sign-up sheet for people interested in the research centre and to describe it. Marilyn will prepare information and sign-up sheets, Aureene will see if she can get name-tags from Extension. -concern about the possible lack of advance information on numbers attending, and the problem this presents with planning. Agreed to request that women preregister, and make available a phone number where they could leave a message that they will be attending (or perhaps not attending)... Marilyn will try to get the phones into the Research Centre House before that date and a telephone answering device on that phone so it could be given out to people.

-maybe one breakout room could be designated a media room, but we did not see setting up phones or doing a great deal of work for this room. See notes on Getting the Word out for other comments.

-agreed the wine and cheese should be informal with no "formal" introductions of people. However, committee members will "hostess", keeping an eye out for participants who not know anyone or ensuring that women who might like to talk to each other are introduced.

See the revised Feminist Research Forum Schedule for other changes.

### 3. Proposed budget -

no major problems, but Dorothy Smith's airfare is now known to be somewhat less expensive than anticipated. It needs to change to reflect that and the honorarium provision. The registration fee should approximately cover the cost of food, so that changes in numbers would not create large problems with the budget. See revised version for changes.

We do not know if the Conference Fund will grant us the dollars requested, but the request has gone in.

4<u>. Possible problem areas</u> were discussed and generally we agreed to work with them. No major problems were seen at this time.

### Getting th Word Out -

-Marilyn to prepare a flyer on the Mac (hopefully which she can get laser printed before reproduction)... it will go to Common Woman Books for distribution to customers, to the Feminist Philosopy Conference, to committee members, and to others who might be interested. (A draft will be presented to the whole committee Tuesday morning for discussion and agreement; it will be completed immediately afterwards).

-Aureene to get mailing lists of women's groups to send information to; this information will likely be the conference brochure rather than the flyer.

-Marilyn to continue to work on the conference brochure; it will be a simple Mac prepared document derived from the working drafts which the commitee(s) are currently viewing and revising.

-Marilyn to write a press release, which should be distributed by Public Affairs. We are proposing one go out after the Labour Day week-end and another just before the conference... this strategy should be discussed with Public Affairs. Reporters who write in this area will be advised of the conference and especially Dorothy Smith's talk. (\*Jan, forgot to ask this, but when you are talking to Dorothy will you check to see if she will speak to reporters?)

Marilyn will continue to work on this session, but it may not proceed.

f) Applied Feminist Research - Andrea has talked to Jane Hazlett at ASWAC and Jane Templeman at Options for Women. Both think they should participate and are willing to try to arrange something. Andrea has asked them to talk about how and where they gather their material and statistics for briefs, and what they have in the way of resources that other people could draw on. Andrea will also see if the nascent Reproductive Technology group in the city would wish to be involved in this session. It looks like it will proceed, but there is a little more work to do on it.

g) Women and Political Involvement - was a new session which was identified as a result of other phone calls. Julia Ann Legras would like to talk about her research on that topic. We thought possibly a session which added a talk on Irene Parlby (maybe Cathy Cavanaugh would look at her research from this perspective) and a talk by someone active in a current woman's campaign could be very good here. Muriel Stanley-Venne's name came up in this context again, as did other women currently running for office. Marilyn and Aureene will try to fill this one out quickly.

h) Feminist Psychology - Jan had talked previously with Cheryl Malmo and Rosaline Spricer and both were quite willing to present work in this area. We suggested adding a third, and Jan will call Rosemary Liburd or maybe Donna Anthony to present their "fifteen minutes"; if Rosemary agrees to be the third maybe Donna would be willing to chair the session.

i) Feminist Theology - Sharon thought that Donna Coolue (sp?) would be interested in talking about her work which overlaps psychology and theology. Sharon will ask her, and Marilyn will approach Fran Hare and Randy Warren at St Steves to see if one of them would be interested. (Note: Jan points out that is the time of Paulo Freire's visit to the city and St Steves is very involved in that; it will likely present problems but we will see if anything can be arranged even so).

If all of these sessions go we will have nine rather than six; we did not see that as a problem as we thought ten to fifteen people in each session would really be the ideal number. That is, we would like a "forum" rather than a "paper's read to an audience" type of conference. If we have nine sessions they will be run as three concurrent sessions in three time slots.

Procedurally, we agreed that the session organizer should now send a letter to each person who has agreed to participate (wheter presenting their research or chairing a session), outlining her expectations and who else would be in the session, and reminding the participants of the dates. Immediately after Thanksgiving a final letter will go to each participant from the overall committee chair, thanking them for agreeing to participate and confirming exact times for their sessions (this will need to be confirmed orally before that date).

Plenary session: generally agreement with the plan presented in the agenda notes, but it will be further discussed in the full committee meeting on Tuesday morning.

2. Opening talk by Dorothy Smith Friday evening. Wine and Cheese to follow. Jan Williamson arranging Dorothy Smith details; Wine and Cheese arrangements not yet made. Begin about 7:30 and go to about 10 p.m. Perhaps registration this evening also.

3. Sessions to run about one hour and fifteen minutes, with three persons presenting or commenting on research. Each session organizer will have flexibility as far as the exact arrangements are concerned. Present plans are for two concurrent sessions to run over three time periods for a total of six sessions. This could be expanded to three concurrent sessions if it appears adviseable. Session times will be:

4. Sessions to include:

b) Margaret-Anne Armour organizing Women and Science (Heidi Kass, Linda Fedigan, Sharon Franzt-Lutzer)

c)Lisa Austin will ask Debbie Shogun about organizing a women and philosophy session, perhaps something from the feminist ethics work, perhaps broader than that.

d)Aureene Costuras will organize a session on research on women in the work-place, with an emphasis on equity efforts at present. (Possible contacts, the equity officer with Dow Chemical, Doris Badir, maybe Women's Secretariat) e)Marilyn Assheton-Smith will contact Athabasca people to see if they would participate in/work on a session. It might be on distance education, or Indian women and education, or some other topic.

f) Andrea will plan a session on resourcing community research, perhaps with Common Women Books, ASWAC, etc.

g) A number of other sessions were mentioned. These included women and technology, especially if Regina Cochrane is back from China in time, Women in Business (with Gayle Greenwood of Greenwood books one possibility, or Dallas Cullen); something from Women in Nursing (perhaps Pat Valentine or Vangie Bergum could be approached), something in psychology, something on women in politics... and so on. However, we agreed to accept the above six sessions as our sessions for the present, but to keep our eyes and ears open if it would be apparent that other sessions could be added.

5. The plenary session will be primarily an information session on the research centre, with a plan for a follow-up meeting which would involve those who wished to be members of the centre. An organizer for that has not yet been identified, but it will need to be someone from the larger committee. There should be a draft brochure on the centre ready by that time, a draft which assumes changes may be made as a result of this meeting or later meetings.

 Registration from 8 a.m. to 9 a.m. on Saturday, and possibly Friday evening. No arrangements have been made for the work involved in this.

7. Food will include the wine and cheese Friday evening, muffins and coffee (etc) from 8 a.m. to 9 a.m., refreshment breaks at 10:15 and 2:15, and sandwich-type lunch laid on from 11:45 a.m. to 1 p.m. No arrangements have been made for the work involved in this, but if funds can be generated we will try to cater it.

8. First publicity has already gone out in the Women's Programme Brochure. Second publicity should be done within a month and a third round of publicity the first week in October. This should include information to a mailing list, as well as possibly something more general. (We should also get it up on the Women's Studies Program Notice Board) 9. Marilyn will draft up a budget for the week-end; Cathy will apply to Community/University projects for funding, and Marilyn will apply to the conference fund. Hopefully, that will provide us with enough funds.

10. We agreed to talk to all people involved in the sessions, and get firm comittments from them before the next meeting. At the next meeting we should have the program firm, and a letter should go out from the committee as a whole outlining the expectations for the week-end.

11.
