I am interested in learning more about the activities of the Committee on Women Studies. As a new faculty member this year, I would like to find out more about the proposed expansion of the programme, the organization of visiting lecturers, and the allocation of resources to the programme. For the past few years, I have been involved with both feminist research and teaching in women studies programmes in Canada and Britain. I was wondering who one should approach, if one had proposals for guest speakers, library resources, or wanted to organize events (e.g. symposia, lectures or possibly a conference) pertaining to the area of Women Studies. I realize that budgets are probably depressingly meagre at the present time, but nonetheless would appreciate knowing what is currently available and being planned.

Dear members of the Women's Studies Committee:

After having attended Paula Kaplan's lecture regarding the myth of masochism in women and after having taken several women's studies courses offered at the University, I have felt the need to become actively involved in the Women's Studies Program on campus. I am presently a graduate student in the English Department and am enrolled in a course entitled "Women's Literary Tradition" which is being offered for the first time this year.

My desire to become involved with the Women's Studies Committee stems from a number of sources, not the least of which is the fact that I am one of thousands of women who are experiencing (and are frustrated by) an education which is approached from a largely male perspective. Indeed, one of the manifest functions of the "Women's Literary Tradition" course is to rewrite the literary canon so that, along with Chaucer, Milton, and Shakespeare (all of whom, of course, are men), we can include Behn, Austen, the Brontës, Eliot, and Woolf (to name a few).

With this in mind, I have recently decided to reapproach Christina Rossetti and her poetry, my M.A. thesis subject, from a feminist perspective which has remained largely undiscussed by literary critics. There is such a vast amount of literature by women that remains untouched in this regard; a fact which is both exciting in terms of the challenge it presents and aggravating in terms of the critical neglect women's literature has received. My interest in the Women's Studies Committee, however, is not solely a literary one. I am also fascinated, for example, with the role that the media plays in the lives of women in regards to their body image and self esteem.

While I understand that the Women's Studies Committee is am established body, I would like to make myself available to you should any kind of participation or assistance be required. Terms of Reference for the Advisory Committee on Women's Studies

Name Change:

Co-ordinating Committee on Women's Studies, University of Alberta

Reporting:

to the Vice-President (Academic)

Terms of Reference:

- 1) to advise on policy generally at the University of Alberta with regard to the development and enhancement of women's studies
- 2) To support and extend existing work in women's studies at the University of Alberta, especially but not limited to the work now being done in the Faculty of Arts
- 3) to facilitate the introduction of women's studies courses and programs in additional faculties at the University of Alberta, especially but not limited to those faculties which currently have very little work being done in the area of women's studies
- 4) to co-ordinate the flow of information related to women's studies within the University of Alberta, particularly across faculties and other university units
- 5) to support the development of feminist research and feminist scholarship at the University of Alberta

6)to provide a liaison structure:

- a) for women's studies at the University of Alberta and women's studies at the other three Alberta universities
- b) with the Western Regional Chair in Women's Studies (located at the Universities of Winnipeg and Manitoba)
- c) between Women's Studies at the University of Alberta and the women's community
- 7) to identify other tasks and responsibilities which will further the development of women's studies knowledge, analysis and incentives at the University of Alberta.

Membership

Committee membership will consist of the following:

Permanent members:

- -Co-ordinator of the Women's Studies Program in the Faculty of Arts
- -Director of the Women's Program and Resource Centre, Faculty of Extension

Ex-officio members:

- -Co-ordinator of Women's Studies, Athabasca University
- -Director of the Women's Secretariat, Government of Alberta

(In all of the four above cases, this person may be replaced by a designate who is working within that program, to be selected by an internal process, provided that such replacement is for at least a year).

- -Six additional academic staff members broadly representing the various faculties, institutes and academic service units of the university. Two should be appointed each year for a three-year term to ensure continuity of membership.
- -Two student members; one graduate student and one undergraduate student
- -Two members from the women's community in the Edmonton area

All members except the permanent members would be formally nominated by the existing committee and recommended to the Vice-President (Academic). Details of the nomination process will be further clarified in the 1986-87 term of operation.

Committee Structure

The chair or co-chairs will be chosen by the committee from within its membership and will normally hold that position for one year. The person(s) elected to the chair may stand for reelection for a second term.

Sub-committees may be struck for specific tasks as they arise. On policy matters, such sub-committees will report back to the full committee for discussion and decision before taking action in the area of their responsibility.


In general, and to the extent it is appropriate for small committees, Robert's Rules of Order will be used to record formal decision-making.

Reporting and Evaluation

A record of all meetings of the committee and its subcommittees will be kept. Such record will indicate the decisions taken and who has accepted responsibility for action, and discussion as the committee deems desireable.

The committee will report annually in writing to the Vice-President (Academic). The full committee may meet annually or as necessary with the Vice-President (Academic) to discuss matters arising from the committees work. The committee may also designate the chair(s) and several members to meet on occasion with the Vice-President Academic.

In the fifth year of the operation (1988-89) of the Committee on Women's Studies the goals and activities of the committee will be reviewed.

New Book Prize Created

In 1987, CRIAW will offer a new prize in honour of Laura Jamieson (1888-1964), British Columbia feminist and political activist. It will be awarded for the best feminist book, by a Canadian author, which advances knowledge and/or understanding of women's experience. The 1986 Anglophone Prize Committee in Vancouver has offered to endow this prize, which will be given in alternate years to French and English authors.

CRIAW's Research Grant recipients 1986

Grants have been awarded to the following projects:

The WAVAW Video, Doug Ekelund and Faye Yoneda, independent researchers, Vancouver, B.C., for the production of a 30-minute video to be used by the Vancouver Women's Collective, Women Against Violence Against Women/Rape Crisis Centre for community outreach work and volunteer training.

The Employment of Native Women at the Norman Wells Project, Linda Lange, Boreal Institute for Northern Studies, Edmonton, Alberta. The Norman Wells Oilfield Expansion and Pipeline Project, 1983-1985, was the first "mega" industrial project in the Northwest Territories. Although there was extensive controversy about training and employment for Native people for this type of employment, no particular attention was paid to the employment problems of women in these communities. The project will study the problems of Native women faced with this type of employment and will also reflect the political context of the Norman Wells project.

Prostitutes as Victims and Possible Solutions, (Ms.) Léo y. Liu, Political Science, Brandon University, Brandon, Manitoba. The project will emphasize prostitutes as social victims and as legal victims, especially as a result of recent revisions in the Criminal Code, and will examine charges laid on prostitutes in Manitoba or central Canada, since the revisions.

The Elements of Pornography: Language and Image, Jillian Ridington, independent researcher, Vancouver, B.C. The project will address two

urgent questions regarding the language and images of pornography as contained in mainstream "men's sophisticate" magazines. The research will be based on material reviewed by the B.C. periodical Review Board during its first two years of existence. The incidence of pornographic language and pornographic images as factors in the Review Board's decisions to recommend against distribution will be compared, and differences in decisions regarding heterosexual and homosexual pornography will be analyzed.

Learning from Women's Perspective: A Cross-cultural Study, Melanie Melamed, independent researcher, Montreal, Quebec. Will examine women's ways of knowing and learning in formal and informal educational settings. Using oral history and interview methods, the researcher will meet with women in Canada and Latin America to learn how they were able to develop beyond traditional female roles into dedicated workers for social change.

Women and Work: An Historical Study of Women Working in Canada in the 1920's and 30's, Barbara Ann Keddy, School of Nursing and Dept. of Sociology and Social Anthropology, Dalhousie University, Halifax, Nova Scotia. Using an oral history approach, older women will be interviewed about their work histories and their life reviews preserved in the Nova Scotia Archives.

Feminist Perspectives on Law: An Annotated Bibliography of Canadian Sources, Susan Boyd, Department of Law, Carleton University, and Elizabeth A. Sheeny, Faculty of Law, University of Ottawa. A bibliography of feminist sources on law will be organized by subject and will include annotations which précis the contents of each entry and evaluate its theoretical and practical contributions.

Visual Documentation of Works by Canadian Women Artists (1700-1986), Natalie Luckyj, Carleton University, Ottawa, Ontario. To write an investigative survey that will consider Canadian women artists' role as educators, social activators and as important innovators and contributors to the development of the fine arts in Canada. Both traditional areas of painting, sculpture, print making and photography, as well as recent installation and video art, will be considered.

The Midnight Operator, Leslie A. Hunt, independent researcher, Vancouver, B.C. The Midnight Operator is a work of fiction, written by L.A. Hunt, concerning the development of the telephone operators' union in 1919 and the role of women in labour history, particularly concentrating on the "equal pay for equal work" movement. Material will be developed through archival research in the Vancouver City Archives and the British Columbia Archives for adaptation of the stage production to film.

Étude démographique et psychologique de la prostitution féminine, Hélène David and Christopher Earls, Département de Psychologie, Université de Montréal, Montreal, Quebec. This demographic/psychological study of prostitution in the Montreal area will involve meeting about 50 women in their workplace and asking them to reply to a questionnaire and three personality tests.

Les rapports financiers entre conjoints: diffusion des resultats d'une recherche préliminaire, Hélène Paré and Lesley Lee, independent researchers, Montreal, Quebec. A study of financial arrangements within couples from the women's point of view, to obtain an overview of the situation in Quebec. To be distributed to interested groups and researchers.

Elaboration et validation d'instruments pour évaluer l'impact d'une ressource post-scolaire destinée aux fillettes âgées de 9 et 12 ans, Claire Chamberland, Ecole de Service Sociale, Université de Montréal, Montreal, Quebec. An after-school project for girls with activities designed to help them acquire a favourable attitude and abilities to engage in problem-solving, and to also improve their level of knowledge in areas related to science and a variety of technologies, will be evaluated.

Marta Danylewycz Grant. The first grant in memory of historian Marta Danylewycz was awarded this year to Frances Ann Swyripa (Dept. of History, University of Alberta) for her research project: "From Peasant Immigrants into Ethnic Canadians: Ukranian Women in Western Canada through the Second World War".

Research Associate Status

CRIAW wishes to remind the membership that Research Associate status may be made available to independent researchers who do not have an institutional affiliation but require one when applying to funding agencies. If interested, please outline your project and background in a letter addressed to the Executive Committee, CRIAW national office, with as much lead-time as possible.

Research priorities established

The CRIAW Board, Executive Committee and Research Committee have been consulting on CRIAW's priorities in building a research institute without walls, and in November, plans for the following projets were adopted as part of our Plan of Action:

1) Fundamental Research - The Feminist Ethics Project: In November 1986, the first meeting of the Feminist Ethics Group took place in Moncton. The composition of the group involved researchers from very diverse backgrounds -- researchers who would not have been brought together except through CRIAW's initiative. At this inaugural meeting, several strands of fundamental concern emerged, including: (i) women's moral decision-making; (ii) the process of generating ethical concepts and theories which reflect the changing roles of women in our society; (iii) the ethical questions raised in the conduct of feminist research; and (iv) issues of methodology in this field. The group will meet again in a workshop session in February 1987 and present a Year One Report in November 1987, CRIAW plans to include a commitment to this area of fundamental research for a three-year period.
