

Employment and Immigration Procedures Concerning Non-Canadian
Distinguished Visitors Approved Under the Endowment Fund for the Future

With regard to the proposed visit of Dr. Dale Spender (London, England) and Dr. Alison M. Jaggar of the University of New Jersey, this is to remind you that the following Employment and Immigration procedures should be followed:

If your proposed visitor is currently a staff member at a non-Canadian university or other post-secondary institution abroad, he/she may be admitted to Canada either as a <u>Visiting Professor</u> or as a <u>Guest Lecturer</u>. Both categories are exempt from advance validation of employment (Form 2151). Your visitor must, however, obtain temporary employment authorization and may require a visitor's visa. Whereas Employment Authorizations which do not require Advance Validation of Employment may now be issued at a Canadian port-of-entry (as of December 3, 1984), visitor's visas for citizens of "Visa Countries" must be issued by a Canadian Consulate or Embassy abroad.

The proposed visitor should therefore be advised to contact the nearest Canadian Consulate or Embassy to ascertain whether a visa is required. If it is not required, he/she may proceed directly to Canada.

When applying for employment authorization, whether at a Canadian portof-entry or a Consulate abroad, the proposed visitor must be in possession of:

- (a) A valid passport (except for U.S. citizens and permanent residents who need only be in possession of identification confirming their citizenship/immigration status in the United States, e.g. birth certificate, S.I.N. card, naturalization papers, etc. A driver's license is not an acceptable item of identification.)
- (b) An appropriate invitation letter from the University of Alberta (see enclosure) indicating the intended length of employment and related honorarium or other form of compensation.
- (c) A statement from the home institution which confirms that he/she will return to a permanent position following the proposed stay in Canada.

Although Employment Authorizations for Visiting Professors and Guest Lecturers may now be issued at port-of-entry, it is nevertheless recommended that, if at all convenient, the documents should be obtained in advance from a Canadian Consulate (particularly if longer visits are involved) so as to eliminate potential problems on arrival.

Distinguished visitors who are not permanently employed staff members at post-secondary institutions, may not qualify for admission to Canada under the Immigration categories of "Visiting Professor" or "Guest Lecturer" and special arrangements may be necessary. In such an event, please contact me immediately.

Please note that your distinguished visitors should <u>not</u> be instructed to come to Canada as <u>Guest Speakers</u>, since the nature of the proposed appointment does not correspond to the pertinent Immigration definition.

Enclosed are sample invitation letters for Distinguished Visiting Professors and Distinguished Guest Lecturers. You are encouraged to use the suggested letters in order to avoid conflicts with Immigration terminology.

Your role as a Distinguished Guest Lecturer at this University should enable you to enter Canada without advance validation of the employment offer and to apply for employment authorization at port-of-entry under Regulation R(20)(5)(e)(iii)E40(b) of the Immigration Manual. [Nevertheless, we recommend that you contact the nearest Canadian Embassy or Consulate prior to departure to verify that you do not require a visitor's visa (which is mandatory for some countries and cannot be issued at port-of-entry). We also recommend, if at all convenient, that you obtain your employment authorization from the Canadian Consulate to avoid unnecessary delays or potential problems on arrival in Canada.]**

Please present this letter when you apply for your employment authorization (Form 1102), whether at a Canadian Consulate or at port-of-entry. You should also have evidence from your home institution to the effect that you are permanently employed there [delete where not applicable].

You must, of course, also be in possession of a valid passport when you enter Canada. (Citizens or permanent residents of the United States do not require a passport but must carry evidence of their citizenship or resident status, such as a birth certificate or naturalization papers. A driver's license does not constitute such evidence.)

If you inform us of the name of your airline, flight number, port-of-entry, and arrival time, we will alert port-of-entry Immigration officials to your visit to avoid unnecessary delays.

Your role as a Distinguished Guest Lecturer at this University should enable you to obtain a visitor's visa and employment authorization (Form 1102) for Canada without advance validation of offer of employment under Regulation $20(5)(e)(iii)\underline{E40}(b)$ of the Immigration Manual. However, Canada's Immigration regulations require that you call at the nearest Canadian Consulate or Embassy to apply for these documents prior to your departure. Please be sure to take this letter with you when you go for the interview, as well as a letter from your home institution confirming that you are a permanently employed staff member there. You also require a valid passport. The Consulate will advise you of any other documents that may be needed.

I would appreciate knowing in advance your airline expenses, the name of the carrier and flight number, port-of-entry, and the date and time of arrival.

Please advise us promptly if any changes occur in your itinerary.

It gives me great pleasure to offer you a temporary appointment as a <u>Distinguished</u>
Visiting Professor in the Department of for the period

In order to comply with Canada's Employment and Immigration regulations, please contact the nearest Canadian Consulate or Visa Office (either by telephone or in writing) with regard to obtaining an employment authorization (Form 1102). As a Distinguished Visiting Professor, you should be exempt from advance validation of employment under Regulation 20(5)(e)(iii), Exemption Code E40(c).

To enter Canada and obtain an Employment Authorization, you require (1) a valid pass-port*, (2) this letter of invitation, and (3) a statement from your home institution confirming that you hold a permanent position there, to which you will return when your appointment at the University of Alberta terminates.

Please also ascertain through the Consulate whether or not (1) you require a Visitor's Visa and/or a medical examination and, if you require neither, whether (2) the Employment Authorization can be issued at a Canadian port-of-entry (provided you are in possession of the above documents).

If you are advised in writing by the Consulate that your Employment Authorization may be issued at a Canadian port-of-entry, please mail us a copy of this information and notify us, in advance, of your expected date and time of arrival, airline, etc. We will then inform the Immigration authorities at this end so as to help in streamlining admission procedures when you arrive.

If you are married and accompanied by your spouse, he/she will not be permitted to work in Canada without advance validation by a Canada Employment Centre of a job offer received. Such validation can only be obtained under exceptional circumstances. Employment by the spouse should not, therefore, be anticipated.

If you are accompanied by school-age children, it will be necessary to obtain Student Authorizations (IMM Form 1208) for them before they attend classes in Canada. These authorizations may be issued either by a Canadian Consulate abroad or by the Canada Immigration Centre in Edmonton upon presentation of a registration form from the separate or public school boards.

Provided you plan to stay for at least one full year, you should normally be able to obtain Alberta Health Care Insurance under the University's group insurance plan. You will be advised by our Payroll Department of the procedures to follow.

Citizens of the United Kingdom are required by Canadian immigration regulations to seek authorization of employment before presenting themselves at a port of entry. To do this you must present "appropriate documentation" at a Canadian consulate. (No doubt you know Canada House at Trafalgar Square.) The "appropriate documentation" consists of this letter, which is your formal invitation to come here as a Distinguished

Visitor, and some evidence that you are permanently resident and employed in the United Kingdom. May I suggest that you perform this exercise reasonably well in advance of your proposed travel, so that if there are any difficulties we can correspond about them.

We do hope that you will be able to accept this invitation, and I join my colleagues in looking forward very much to having you with us. in 1986.

Nominations for Distinguished Visitors

On behalf of the Vice-President's (Academic) Advisory Committee on Women's Studies, I wish to nominate the following two individuals as Distinguished Visitors for the 1985-86 academic year:

Dr. Dale Spender

Dr. Spender holds a B.A. and Dip.Ed. from the University of Sydney in Australia and a B.Litt from the University of New England. She holds an M.A. from the University of New South Wales and a Ph.D. from the University of London.

She is based in London, England, and is the founding editor of Women's Studies International Forum, a multi-disciplinary and scholarly Women's Studies journal. She is a prolific writer and since 1980 she has authored or edited no less than eight books including the influential Man Made Language (1980 and Women of Ideas and What Men Have Done to Them (1982). She also has two more books in press and one forthcoming.

Dr. Spender is at the leading edge in terms of critical analyses of the ways in which women's ideas have been shaped, distorted and sometimes erased as a consequence of their less powerful position in the social construction of knowledge and meaning. The nature of her analysis has relevance not only to those in the social sciences but to those in the humanities and fine arts as well.

Dr. Spender's curriculum vitae is enclosed.

Dr. Alison M. Jaggar

Dr. Jaggar holds a B.A.(Hon) from London University, an M.Litt from Edinburgh University and a Ph.D. from S.U.N.Y. (Buffalo). She is a Professor of Philosophy and the Wilson Professor of Ethics at the University of Cincinnati. Presently she holds the New Jersey State Endowed Chair in Women's Studies at Douglass College, Rutgers University where she is also a Visiting Professor of Philosophy.

Dr. Jaggar is a political philosopher and in addition to her many articles, she is the author of two very well received books: Feminist Frameworks (with Paula R. Struhl) published in 1978 and Feminist Politics and Human Nature which was published in 1983. She has an international reputation for her work in political philosophy and feminist theory.

Dr. Jaggar's curriculum vitae is enclosed.

Also enclosed are the many letters of support we have received for both of these nominations.

In addition we have spoken with both Drs. Spender and Jaggar by phone and they are keen to come to the University of Alberta, each for a two-week period. We would like to have Dr. Spender here in September 1985 and Dr. Jaggar in March 1986.


