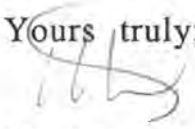

Dear Ms. Dolinsky,

Thank you for your letter of February 20th. I can understand your frustration at dealing with our various claims for issues of the **Canadian Women's Periodicals Index**. In order to give you an adequate reply I must back-track a little.

In 1990 I was informed that the UBC President's office had taken out an Educational Institutional membership in CRIAW and that, as a result, we would be receiving three copies of your various publications including the **Canadian Women's Periodicals Index**. We set up the required management records and started checking in the issues as they were received. Whenever an issue was not received a claim notice was sent to you. Subsequent correspondence over claimed issues shows that there has been some confusion at your end as to our membership status and the address to which the index should be sent (see letters of 2Mar90 and 13Sep92).

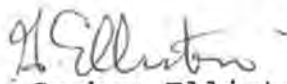
Here is how things stand now.

- 1) **First set (M9863176-0):**
Holdings complete to v.8 no.1 (July 1992)
- 2) **Second set (M9863176-1):**
We have: v.6-v.7 no.3 (May/Aug 1990-Jan/Apr 1992)
Need: v.8 n.1 (July 1992)
- 3) **Third set (M9863176-2):**
We have: v.5 no.1-v.6 no.2 (lacking v.5 no.2)
Need: v.5 no.2 and v.6 no.3-v.8 no.1

As I've already said, we set up our records originally on the assumption that we would be receiving three copies of each issue. Please let me know if we were mistaken in this. If we are entitled to only two copies we shall have to make do with that, as we are in no position to pay for the third.

Please let me know how things stand and I shall revise our records accordingly.
