First of all, may I suggest that you include salient order information on each periodical represented in CWPI, similar to the information provided in each issue of Feminist periodicals? I am including a photocopy of an excerpt from FP's listing as a sample for you.

As you know, not all Canadian women's periodicals are so easily tracked down by simply conferring in Ulrich's. It seems a pity to me, that your publication goes to such great lengths to document title pages and to provide a KWOC index, yet there is no avenue provided in the same issue for obtaining the periodical.

Secondly, I am confused by the great disparity in your periodicals listing between your May/August '89 issue and your Jan./April '89 issue. May I propose that you continue to include an explanatory paragraph at the head of your lists, with a triple set of asterisks:






